

FORMAL PRIOR RECOGNITION LETTER

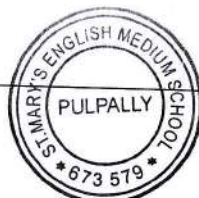
